2025 Turkish Festival – Bazaar Vendor Rules & Guidelines

Sunday, October 19, 2025 | Washington, D.C.

To ensure a successful and well-organized Bazaar experience, all participating vendors are asked to review and follow the guidelines below:

- **Product Theme:** All items sold must be of **Turkish origin** or clearly reflect a **Turkish theme**.
- **Active Participation:** Only vendors who are **actively presenting and/or selling products** may participate in the Bazaar.
- **Booth Setup:**
 - The Festival Committee will provide **tents, tables, and chairs** for vendors.
 - Vendors may choose between renting a **single table or a 10' x 10' booth space**, which includes **three tables and two chairs**.
- **Space Selection:** Vendor booth locations will be selected on a **first-come, first-served** basis.
- **Display Requirements:**
 - Vendors must bring their own **signage** and **display materials**.
 - **All tables must be covered**, and vendors are responsible for providing their **own table coverings**.
- **Electricity:** **No electrical outlets** will be available at the Bazaar.
- **Sales Tax:** Vendors are responsible for collecting and paying **DC Sales Tax** on items sold. ATA-DC will submit all vendor names and Tax Identification Numbers to the DC government in advance.

- **Restricted Items:** Vendors are not permitted to sell **Turkey-themed T-shirts**, as ATA-DC reserves the exclusive right to offer these items at the Festival.
- **Service Providers:** Businesses such as **law firms, accountants, travel agencies**, etc., may only participate through **Festival sponsorship**.
- **Cancellation Policy:** Cancellations made **after August 31, 2025, are non-refundable**.

Please note: The Festival Committee reserves the right to disqualify any vendor who fails to comply with these rules.

2025 Turkish Festival – Festival Day Guidelines for Bazaar Vendors

Sunday, October 19, 2025 | Washington, D.C.

To ensure a smooth and successful event, please carefully review the following day-of guidelines:

Arrival & Setup

- **Loading/Setup Time:** Vendors must arrive between **9:00 AM and 10:00 AM** to access the festival site for setup.
- **Late Arrival Policy:** Vendors arriving **after 10:00 AM will forfeit their space** without a refund.
- **Setup Deadline:** All tables and displays must be fully set up by **10:45 AM**. The Festival opens to the public at **11:00 AM** sharp.

Festival Site Access

- You will receive a **vehicle access permit** prior to the event.
- Please **display the permit clearly on your car's dashboard** to enter the site for unloading.
- **Unloading must be completed by 10:00 AM**. After that time, **no vehicles will be allowed** on Pennsylvania Avenue.
- You must park your vehicle in a nearby public parking facility after unloading.

Your Vendor Space

- **A label/tag will be placed on your assigned table(s)** to designate your reserved space.
- **Changing spaces is not permitted.**
- **Signage:** You are welcome to bring your own signage and branding materials.
- **Display Tips:** Because space behind tables may be limited, consider using **table-top displays** or **freestanding racks**.
- **Table Covers:** ATA-DC will provide **table coverings** for all vendor tables.

Dismantling & Load-Out

- Vendor booths will begin dismantling around **7:15 PM**, coordinated by the company providing the tents and tables.
- Please ensure your items are packed up promptly and your space is left clean.

Table (~3ft x 6ft) There will be 3 feet space between tables	\$425 per table
10ft x 10ft space It will be on a corner section of the tent and include three tables and two chairs	\$650 per space
